Discounted Room Rate:

Foryourconvenience, ACPA has contracted a block of rooms at the discounted rate of \$209/night plus applicable taxes. The cutoff date for hotel reservations is August 18, 2016. Individuals are asked to make their own hotel reservations by calling the Gaylord Opryland Resort directly. The block of rooms is limited. Make your hotel reservations as soon as possible.

Room Deposit/Cancellation Policy:

A deposit of the first night's room rate plus tax will be taken at the time your reservation is made. Cancellations occurring at least three days prior to arrival will be refunded.

Airport Information:

Nashville International Airport (BNA) is the closest airport to the Gaylord Opryland. The airport is 8.3 miles north of the hotel and travel to and from the airport will take approximately 15 minutes.

Ground Transportation:

Gaylord Opryland does offer transportation to/from the airport. The shuttle runs every 30 minutes starting at 5:30 am. The cost is \$19/one way or \$30/round trip. You can access the shuttle by following the ground transportation signage at the airport.

The estimated taxi fare to/from the airport is approximately \$30 each way. A Hertz Car Rental is located at the Gaylord Opryland.

Hotel Parking Information:

Gaylord Opryland offers on-site parking for \$24 per day. Valet parking is \$32 per day.
